The transition is expected to take place in the first quarter of 2026, subject to the required regulatory approvals from the Mandatory Provident Fund Schemes Authority and the Securities and Futures Commission.

Scheme members will benefit from BCT's holistic retirement solution offerings and top-notch customer services as a result of these changes. Amidst an increasingly competitive MPF market, this relationship will strengthen BCT's strategic position, making BCT a major MPF provider with HKD164 billion in assets under management and 12.4% market share<sup>2</sup>. This will lead to greater scale and a broader pension distribution network.

"In recent years, we have been at the forefront of digital innovation, launching the revamped bct+ mobile app and the industry-first Al Advisor Mario. This relationship accelerates our growth in the MPF market, positioning BCT to drive further innovation throughout the eMPF journey. Looking ahead, we remain dedicated to empowering our clients to navigate their retirement journey with confidence and achieve their retirement goals."
